

Race Day Scratch Play Sponsored Race (the “Sweepstakes”)

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. Online Registrations Only. A purchase will not increase your chances of winning. Void where prohibited or restricted by law.

SPONSOR: Race Day Scratch Play, 127 W. Fairbanks Avenue, Suite 280, Winter Park, FL 32789 (“Sponsor”).

PRIZE PROVIDER: Race Day Scratch Play, 127 W. Fairbanks Avenue, Suite 280, Winter Park, FL 32789 (“Prize Provider”).

SWEEPSTAKES ADMINISTRATOR: Race Day Scratch Play, 127 W. Fairbanks Avenue, Suite 280, Winter Park, FL 32789 (“Administrator”).

1. TIMING: The Sweepstakes begins 30 days prior to the sponsored race. (“Sweepstakes Period”).

2. HOW TO ENTER: Visit website www.RDSPplay.com (the “Sweepstakes Site”) and complete a registration form. If playing on the mobile app, select whether or not one has a promo code. If playing with a code, enter the code to compete for the next, upcoming Sprint Cup race. If playing without a code, click that box and select the series and race desired in which to compete. Each race has its own grand prize and a pop up will notify the player of the grand prize for that race. If playing a game card, enter the numbers and control code printed on the card at the time of registration. In order to compete, a player must register prior to the start of the race played. If playing with a code, entries after the start will be entered into the following sponsored Race. A player may register utilizing their Facebook, Twitter or Gmail accounts or by their own email account. Completed registration form must be submitted in accordance with the online directions during the Sweepstakes Period. Use of a profane username or the submission of false or misleading personal information by a Participant will be grounds for disqualification. Determination of information to be profane, false, or misleading is at the sole discretion of the Sponsor. Participants must complete all required data. Incomplete or inaccurate entries are void. Limit one registration per sponsored race per name/email address. Registration is the players’ authorization to allow correspondence and push notifications from Race Day Scratch Play and their sponsor. The grand prize will be awarded to a fan whose 5 starting positions finish the race as the top 5, in order, according to the official results of the race played. Sponsored Facebook likes require the top 3 finishers, in order. One winning player will be awarded with each race.

3. ELIGIBILITY: To enter the Sweepstakes you must be at least eighteen (18) or the parent and/or legal guardian (“Parent”) of a child under eighteen at the time of registration (“Participant”). Sponsor, Administrator, Prize Provider and any other prize providers associated with the Sweepstakes, and all of their respective affiliates, parent, and subsidiary companies, licensors, distributors, divisions and their advertising, production and promotion agencies (collectively, “Sweepstakes Entities”), and each of their respective officers, directors, licensors, employees, representatives and agents, and members of their immediate families (parents, step parents, children, step children, siblings, step siblings, spouses, regardless of where they reside) and members of their households (whether related or not) and those winners who have won a grand prize in any Sponsor-related sweepstakes/promotion in the twelve (12) months prior to the start of the Sweepstakes Period are ineligible to participate in this Sweepstakes. Eligibility will be determined by Sponsor and/or Administrator in its/their sole discretion. Any Participant who is under the age of majority in their state of residence (“Minor”), must have the permission of his/her Parent prior to registration and such Registration shall be deemed submitted by the Parent and shall be treated as if the Parent had made such Registration.

4. WINNER AND NOTIFICATION/ODDS: Administrator will notify by email or telephone on or about three days from the conclusion of the sponsored race. No messages will be left on Potential Winner’s voice messaging system. Odds of winning the grand prize are 115,511,760:1. If a Potential Winner cannot be contacted or does not respond within three (3) business days of Administrator’s first attempt, such Potential

Winner and Registration will be disqualified and another Potential Winner will be selected from the remaining eligible Entries received. There will only be one grand prize awarded per race. In the unlikely event of a tie, the last three numbers of the control code will be used to break the tie. Add the last two numeric digits together; the lowest cumulative score will be deemed the winner. In the event a tie remains, winner will be selected by random drawing.

5. QUALIFICATION OF WINNER: Before a Potential Winner will be deemed an Official Winner, he/she will be required to execute and return an Affidavit of Eligibility, a Liability Release/Publicity Release (except where prohibited) (the "Affidavit/Release") and any other legal documents that Sponsor may require, including, but not limited to, a W-9 tax form, within three (3) business days from the date Sponsor sends such documents to the Potential Winner or be subject to disqualification. The Potential Winner must be able to provide proof that the Potential Winner is eligible to be deemed an Official Winner to Sponsor and/or Administrator's satisfaction. If the documents are not returned within that time, or Potential Winner or Official Winner is found to be ineligible, or does not comply with the Official Rules, then he/she will be disqualified and an alternate Potential Winner may be selected.

6. PRIZES: (1) Grand Prize: Grand Prize Winner ("GP Winner") will receive the announced grand prize. This prize ranges from \$1,000.00 up to \$25,000.00, for instance, depending on the sponsorship for that particular race. Every race posted will have a minimum grand prize of \$1,000.00. (2) Second Chance Prize: Registrants have the chance, on sponsored races, to "like" the sponsor on Facebook. If any 3 of that person's five starting positions end the race as the top 3, in order, that person will win the second chance prize and the winner will only be announced on Facebook. If the player shared his game experience with the Facebook like, the prize is increased to \$2,500. It's the winner's responsibility to contact the Sweepstakes Administrator to claim their prize. Should the player choose to share their entry through Facebook and 5 or more of their friends register to play, the prize will elevate to \$5,000.00 for the initial registrant. Cash prizes will be awarded in monthly increments of \$1,000 commencing 60 days after the winning race and continue until the total prize has been awarded.

7. GENERAL PRIZE CONDITIONS/RESTRICTIONS: Limit one (1) Prize per winner/household. Any Participant who is under the age of majority in their state of residence ("Minor"), must have the permission of his/her Parent prior to registration and such Registration shall be deemed submitted by the Parent and shall be treated as if the Parent had made such Registration.

Sweepstakes Entities are not responsible for any mechanical difficulties or failure connected with any Prize, or any act or omission whatsoever. No transfer, substitution, or cash equivalent for any Prize is allowed except at Sponsor's sole discretion. Sponsor reserves the right in its sole and absolute discretion, to substitute a Prize or Prize component with a prize of equal or greater value. Prize is non-transferable and may not be given, bartered, substituted, sold, or exchanged for cash or another prize.

In the event that a Potential Winner chooses not to accept his/her prize, or is unable to be notified, an alternate Potential Winner will be randomly selected from any of the remaining eligible winning Entries.

8. SWEEPSTAKES CONDITIONS: Participants must complete all required data. Entries that have been tampered with or altered shall be rendered void. Sponsor is not responsible for any problems or technical malfunctions, human error, lost/delayed data transmission, omission, interruption, deletion, defect, line failures of any telephone network, computer on-line systems, servers or providers, computer equipment, software, failure of Participants on account of technical problems or traffic congestion on the internet or at any web site or any combination thereof, including injury or damage to participants or to any other person's computer related to or resulting from participating or downloading materials contained in this Sweepstakes.

If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other cause beyond the control of

the Sponsors which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, Sponsors reserve the right at their sole discretion to cancel, terminate, modify or suspend the Sweepstakes. In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, the Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Sweepstakes and award the Prizes from among the eligible entries received up to the time of the impairment. Should the Sweepstakes be terminated or cancelled prior to the stated expiration date, notice will be posted on the website.

In the event of a dispute regarding entries received from multiple users having the same email account, the authorized subscriber of the email account at the time of registration will be deemed to be the entrant and must comply with these rules. Authorized subscriber is the natural person who is assigned the e-mail address by the Internet Service Provider (ISP) or any other provider or other organization responsible for assigning accounts.

Entries generated by a script, computer programs, macro, programmed, robotic or other automated means will be disqualified. The use of any system or agent to submit online entries in connection with this Sweepstakes is prohibited and will result in disqualification. By submitting a Registration, each Participant (whether declared an Official Winner or not) agrees (and agrees to affirm such in writing) to (i) abide by and be bound by these Official Rules and the decisions of the Sponsor on all matters relating to this Sweepstakes which decisions are final and binding in all respects, (ii) waive any right to claim ambiguity in the Sweepstakes or these Official Rules, (iii) forever and irrevocably release, discharge, indemnify and hold harmless the Sweepstakes Entities, and each of their respective officers, directors, licensors, employees, representatives and agents (the "Released Parties") from any liability, claims, demands, and cause of action from personal injury, loss or damage, including death, or property damage, theft, or loss suffered or resulting in whole or in part, directly or indirectly, from participation in this Sweepstakes or the use, misuse or acceptance or possession of any Prize or any portion thereof, or participation in any Sweepstakes-related activity; (iv) grant Sponsor (where permitted by law) the right to use their name, address (city and state only), and biographical information on a worldwide basis, in all forms of media, in perpetuity and for advertising or promotional purposes without review or further compensation and, (v) warrant and represent that the use of the materials submitted in this Sweepstakes will not violate the rights of any third parties. Entries must be in keeping with Sponsor's positive image, as determined by Sponsor and Administrator in their sole discretion. Any materials containing obscenity, crude language, or descriptions of a violent or sexual nature (as defined solely by Sponsor or Administrator) will not be accepted and the associated Registration will be disqualified. All federal, state or other tax liabilities (including income taxes) arising from the Prizes contained in this Sweepstakes will be solely the responsibility of the GP Winner. Receipt of any of the prize components of this Sweepstakes is conditioned upon compliance with any and all applicable federal, state and local laws, rules, and regulations. Noncompliance with any of the above will result in disqualification.

9. LIMITATIONS OF LIABILITY: Released Parties are not responsible for any claims, damages, lawsuits, causes of action, proceedings, or liability due to any injuries, theft, damages, expenses, costs, or losses to any person (including death) or property of any kind resulting from, arising from, or in connection with, in whole or in part, directly or indirectly, from i) any typographical or other error in the printing of the Official Rules, offering or announcement of any prize, ii) lost, late, stolen, misdirected, damaged, incomplete or garbled Entries, iii) any error in the collection or retention of registration information, including, but not limited to, incorrect or inaccurate transcription, receipt or transmission of any part of the Registration due to human error, iv) any wrongful, negligent, or unauthorized act or omission on the part of any of the Sweepstakes Entities, or any of their agents or employees, v) the Sweepstakes and any elements thereof, and the participation or inability to participate in any Sweepstakes-related activity or participation in this Sweepstakes, including, but not limited to, any damage to Participant's (or any third person's) telephone system and/or its contents related to or resulting from any part of the Sweepstakes, vi) any malfunction of the telephone system, whether technical or due to human error in nature, lost/delayed data transmission, omissions, interruptions, deletion, defect, line failures, postponement, cancellation, or modification of the Sweepstakes, including, but not limited to, interruption or inability to access the Sweepstakes due to hardware or software compatibility problems of any telephone network (TSP), computer online systems (ISP), servers or providers, computer equipment, software, failure on account of technical problems or traffic congestion on the internet or at any website or any combination thereof, including injury or damage to participants or to any other person's telephone system related to or resulting from participating, vii) acceptance, receipt, possession, attendance at, travel related to, defects in, misuse, inability to use, or use of

any Prize element contained in the Prize including, but not limited to, lost, stolen, damaged, delayed, or misdirected or destroyed Prize (or any element thereof), or viii) any change in the prizing (or any components thereof) due to unavailability, any of which is due to reasons beyond Sweepstakes Entities' control, including, but not limited to, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not such action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure including but not limited to overloading of the Sweepstakes Site due to excessive use, threatened or actual terrorist acts, air raid(s), blackout(s), act(s) of public enemy, earthquake, war (declared or undeclared), fire, flood, epidemic(s), explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any other cause beyond any of the Sweepstakes Entities' sole and reasonable control, or as otherwise permitted in these Official Rules.

GP Winner hereby acknowledge that the Sweepstakes Entities have neither made nor are in any manner responsible or liable for any express or implied warranty, representation or guarantee, express or implied, in fact or in law, relative to the prize or any component thereof. GP Winner assumes all liability for any injury or damage caused, or claimed to be caused, by participating in this Sweepstakes or use or redemption of the Grand Prize. In the event a Potential Winner or Official Winner is disqualified for any reason under the provisions of these Official Rules, such Potential Winner or Official Winner and all rights to any Prize will be forfeited in its entirety.

Sponsor reserves the right in its sole discretion to disqualify any individual that Sponsor or Administrator find to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserve the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. GOVERNING LAW/JURISDICTION. The Sweepstakes and these Official Rules are governed by and shall be construed in accordance with the substantive laws of the State of Florida (as distinguished from the choice of law rules) and the United States of America applicable to contracts made and performed entirely in Florida and where the relevant contacts are with such state. Except where prohibited, as a condition of participating in this Sweepstakes, each Participant agrees that any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, the Prizes awarded, or the determination of the Official Winner shall be resolved individually, without resort to any form of class action. Participant further agrees that in any cause of action, the Sweepstakes Entities' entire liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Sweepstakes Entities be liable for attorneys' fees and/or experts' fees and costs. Participant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages and Participant further waives all rights to have damages multiplied or increased.

information collected or used in connection with the Sweepstakes may be used by Race Day Scratch Play and participating sponsors.
